Welcome and Introductions

The Chair welcomed attendees to the February Assurance Framework Board meeting.

Report from the Chief Executive Officer

Ian Hutchison provided an update on the operational situation and system pressures which remain challenging. Ian Hutchison talked about the Community Services Review. There has been discussion about the MSK pathway development and the collaboration with NCH&C which has strengthened over recent months.

Updates from the Board Sub-Committees

The Non-Executive Director Chairs of the Board sub-committees provided the Chair's Assurance Report from each Committee for review and assurance and talked about the progress made in all areas of reporting.
